Art. 1

Competition places

The technologist, within the framework of the directives given to him/her by the Project Manager, will have to deal with: Technical support, review and analysis activities related to the research project.

- 4) documented professional experience of at least three years in the field of sequencing with third generation nanopore technology applied to the study of blood neoplasms; experience in using droplet digital PCR (ddPCR);
- 5) age under 40 years;
- 6) residence in a geographical area of Southern Italy;

- 9) possession of civil and political rights. For applicants who are not Italian citizens and do not hold refugee or subsidiary protection status, the possession of civil and political rights refers to the country of citizenship.

Article 3

Each application will be assigned with an identification number which, together with the competition code indicated in the IT application, must be specified for any subsequent communication. At the end of submission deadline, the system will no longer allow access and submission of the electronic form. No other forms of sending applications or useful documents for participating in the procedure are allowed.

In case of access to the platform via SPID, the procedure will not require a signature; in all other cases, the application must be signed:

Statement to be made in the application

In the application, the candidate must declare under his/her own responsibility:

Art. 5

Evaluation of qualifications

Qualifications will be awarded an overall score of 30 points.

The categories of qualifications that can be evaluated, as long as they are relevant to the activities of the available places, are as follows:

- 1) educational and training qualifications up to a maximum 10 points;
- 2) professional experiences up to a maximum of 12 points;
- 3) technical or specialist qualifications up to 8 points.

Art. 6

Selection Commission

The Selection Board of the competition will be appointed by Decree of the General Director according to the provisions in force on the subject. The same one will deal, among other things, with the assessment of the admission requirement referred to in the previous art. 2, first paragraph, point 4).

Article 7

Examinations

The exams will consist of a written test and an oral test.

The written test will focus on Molecular mechanisms underlying the pathogenesis and progression of hematologic neoplasms.

The oral test will focus on Techniques for the study of molecular alterations underlying the pathogenesis and progression of hematological neoplasms, on the Statute of the University of Bari Aldo Moro. During the oral test, the knowledge of the English language and the use of IT equipment and the most popular application and data management software will be verified.

During the exams, behavioural skills, including relational skills, and attitudes will be assessed; the same will be aimed at ascertaining the possession of skills understood as a set of logical-technical knowledge and skills.

The Administration may arrange for the tests to be held through the use of computer and digital tools.

Art. 8*Calendar of tests*

The tests will be held according to the following schedule:

written test: 3rd June 2024 at 11:00 am;

oral exam: 10th June 2024 at 11:00 am.

The tests will be carried out in the meeting room of the Hematology laboratory, located on the third floor of the Morgagni Pavilion at the Polyclinic of Bari, Piazza Giulio Cesare, Bari.

Candidates who obtain a score of at least 21 out of 30 in the written test will be admitted to the oral test.

At the time of the written test the Commission will communicate the date of publication of the list of candidates admitted to the oral test. If there is an impediment which affects the publication of the aforesaid list of candidates admitted to the oral test, a postponement of the notice and/or any postponement of the date of completion of the oral test will be published on the same date.

The oral test will be considered passed if the candidates obtain a minimum score of 21 out of 30.

To be admitted to the exams, candidates must be in possession of one of the following identification documents: identity card, passport, driving licence, nautical licence, firearms licence, identification cards, as long as they have a photograph and stamp or other equivalent signature, issued by a State administration.

Non attendance at the tests will be considered as renunciation of the competition.

Art. 9*Preferences with equal merit*

Candidates who intend to assert the qualifications that give the right to preference with equal merit must indicate them in the application to participate in the competition. It should also be noted that mendacious or false statements, as well as being punishable under the Penal Code and special laws on the matter, may in the most serious cases lead to temporary disqualification from public office, without prejudice to the forfeiture of any benefits resulting from the provision issued on the basis of the false declaration.

The preferential titles that give the right to preference, in the event of equal score, are the following:

- a) those awarded with the medal for military valor and for civilian valor, if they have left the service;
- b) mutilated and disabled for service in the public and private sectors;
- c) the orphans of the fallen and the children of the mutilated, disabled and permanently unable to work for reasons of service in the public and private sectors, including the children of those in the health professions, social workers and social and health workers who died as a result of SarsCov-2 infection contracted in the service of their work;

- e) greater number of dependent children;
- f) disabled and mutilated civilians who do not fall under point b);

Art. 10

Approval of the deeds and of the merit ranking
